# Unsanitary/filthy conditions around CHE

Good afternoon,

I am writing to request that something be done about the unsanitary and filthy conditions around the City building complexes generally and around CHE specifically. This email was prompted by my seeing a large pile of human feces on the sidewalk near the bus stop across from City Hall South while walking to Court this morning. It looked and smelled disgusting and I imagine unsanitary.

I commute to work daily and walk from Union Station to CHE. I routinely smell and see human feces and urine on the sidewalk, and floors and walls of the LA Mall entrances and near the entrances to CHE. On some mornings, the sidewalk, floors and stairs of the CHE entrances have been hosed down and are wet. Though I try not to step on the wet parts, it is usually unavoidable and some of the effluent (which is likely filled with germs/contaminants) ends up splashing on the bare skin of my legs. And I am left feeling revolted and uneasy.

I very much sympathize with the plight of our homeless population and understand that homelessness is an issue that needs to be addressed broadly and systemically. In addition, coming from an underprivileged background myself, I am not at all squeamish or easily put off. However, the unsanitary conditions around our City building complex are worsening and based on my conversations with fellow City employees, are reducing moral and reflect poorly on our great City. Those of us who work at CHE shouldn't have to see and smell or otherwise be exposed to human feces and urine at the entrances of and around our City building complex.

The primary sanitary issue I am requesting be addressed is the urinating and defecating near or at the entrances of the City building complex, including CHE. It goes without saying that when nature calls, one has to answer, even if it is in the middle of sidewalk across from City Hall South! As such, perhaps one possible solution is to provide clearly visible bathrooms that are easily accessible and available for use by the homeless 24 hours a day. I understand that a myriad of logistical and financial obstacles may need to be overcome in order to do so but the idea should at least be explored or some other solution be implemented for the good of those who work in these buildings and for the public.

I am forwarding this email to you that one of my secretaries, Brenda Perez, send to Cory and I. Cory is going to forward it to Hugo and Leela. Does management have any updates on how they intend to protect the safety of their employees? The other night when I was leaving on the 2nd floor there was a man smoking a crack pipe right on the benches outside the 2nd floor doors. I went back in to tell the guards, and they didn't seem overly concerned, nor did they get up to investigate, at least while I was still there.

All the employees' safety is at risk day and night outside. I still have one solution that will keep us safe from the drama outside. "GATES" See the attached picture of a marine base with metal gates surrounding the building, in a nice area in Pasadena where they want to keep out intruders. The City can post guards at the openings to monitor people who are coming in to conduct business here, and escort them to the elevator as they do in the LAPD Headquarters building across the street. I can dream...

It's so overwhelmingly distressing. Please advise as to what I can tell Brenda.

I did not report it to security because I don't think I was in grave danger but nonetheless I think it's important to know what to do in those situations. Hope this does not happen again. 😊

REGARDING: Incident at LA Mall ATM - Involving Aggressive Panhandling

Yesterday evening, March 19, 2019, at approximately 4:50 p.m., I went to use the ATM just outside of City Hall East (CHE), first floor. Upon exiting the building, I noticed two older white males who appeared to be transient, sitting on the bench just outside of the first floor entry/exit doors. I then headed to the ATM located approximately 100 feet away. As I walked over to the ATM, I observed no other people besides the two men.

Midway through my ATM transaction, out of nowhere a third man appeared. He came close to me, approximately 5 feet away, and began asking me for change. I told him I had no money. He then suggested that I get change from the store inside City Hall East (Trimana). I said that it was probably closed.

He did not move from his position and continued to watch me as the ATM dispensed cash and I took the cash, putting it in my pocket.

At this point, I became very apprehensive. I had no idea whether he knew the other two men. I do know that I felt extremely uncomfortable being alone near a cash machine and being stared down as I put cash in my pocket, with two other transient males in close proximity.

As I started to walk away from the ATM and back towards CHE, this third man started following me and stated out loud, "I really wish you had some change."

Being followed by one man and having to pass two additional men, all three of whom appeared to be transient, I was extremely nervous and worried for my safety.

As I entered the building, the first thing I noticed was that the security post was un-manned. No security guard was present. I looked at my phone; it was 4:53 p.m. I then remembered that when I initially exited CHE, there was no security guard present at that time either.

My question: Where was security?

It would've been helpful to have someone there to report this incident and to keep a closer eye on activities occurring just outside the doors, or at the very least, call for extra security.

This morning, I called the security desk on the second floor. They told me that first floor security should be present from the hours of 7:00 a.m. to 5:00 p.m. And that the Mall officially closes at 5 p.m.

All City employees should have peace of mind that, at least during business hours, security is present.

I just went around City Hall East taking these photographs. The first photograph depicts an area where Patty Bilgin saw 3 dead baby mice that fell out of the tree above a couple months ago. Pictures 2-5 show areas around City Hall East (near entrances and exits including the parking garage where there are Terminix boxes possibly rat traps. These traps aren't even in the areas where vermon live. What are these boxes and what is our exposure given they are so close to entrance/exits of City Hall East? The rest of the pictures are of planters outside City Hall East across the street from City Hall. I personally and on more than one occasion have have seen rats jumping up out of these planters as I returned from court. I was too afraid to take pictures of the homeless people and their proximity to the entrances and exits of City Hall. There is one particular homeless woman and others who sit on a bench right next to the entrance/exit for the first floor to City Hall East. The other exits on the first floor have been closed. If you enter or exit from the second floor you have to pass numerous homeless people. Last week she got up to walk away and she smelled heavily of recent piss and urine from that same bench. I am quite concerned for not only my health and welfare but the welfare of my colleagues working at City Hall East given the typhoid epidemic downtown identified by County health and the recent news footage involving same. I have been here at City Hall East about four years. The carpet is disgusting. I have personally asked Sarkis Aleksanian about having the carpets cleaned. He stated to me that he had inquired and was told no. The carpet has not been cleaned. I am concerned about what is being tracked in especially with our proximity to the homeless. There are no janitorial services. Has anybody contacted vector control? Are there any plans to clean carpets, etc. Are there any plans to exterminate?
